Under NO CIRCUMSTANCE is any applicant to make physical connection between any private water system and Norway Public Service Commission water system. Norway Public Service Commission has the authority to refuse service to any applicant who tampers with a meter or other measuring device. The Town will have final jurisdiction in any question of location of any service line connection to its distribution system, determination of allocations of water to members in the event of a water shortage and may shut off the water to a member who allows a connection or extension to be made to/from his/her service line for the purpose of supplying water to another user. Failure to pay Norway PSC charges will result in disconnection and reconnection fees will apply. Service may be cancelled and/or discontinued by Norway PSC for any violation of any rule, regulation, misrepresentation in application, tampering, connections, cross-connections, etc. You agree to the Town of Norway's Public Service Commission ordinances and regulations determined by the councilmembers.

Customer Agreement/Service Contract Addendum

By signing this application for water, sewer, and/or garbage, the applicant agrees to pay all costs of collection of the applicant's unpaid bills. The Town of Norway has the right pursuant to the South Carolina Setoff Debt Collection Act to collect any sum due and owed by the applicant through offset of the applicant's state income tax refund. If the Town of Norway chooses to pursue debts owed by the applicant through the Setoff Debt Collection Act, the applicant agrees to pay all fees and costs incurred through the setoff process, including fees charged by the Department of Revenue, the Municipal Association of South Carolina, and/or the Town of Norway. If the Town of Norway chooses to pursue debts in a manner other than setoff, the applicant agrees to pay the costs and fees associated with the selected manner as well.
