- 1. Meeting called to order at 7:02 PM by Mayor Clemons.
- 2. Members Present: Mayor Tracie Clemons, Councilperson Berley James, Councilperson Bonnie Fogle, and Councilperson Gregg Covington. Absent Councilperson Kelvin Crosby.
- 3. Councilperson Berley James led the invocation.
- 4. Mayor Clemons asked that the agenda be approved. Councilperson Covington made the motion to accept the agenda as written. Councilperson Fogle seconded the motion. All in favor, so moved.
